Each week, more than 300 households receive food from the Intown Food Programs. In Fiscal Year 2022, Intown's Food Programs served 2,044 individuals and distributed 290,867 meals. Intown's Homeless Services Program works to end homelessness for our neighbors living on the streets of the City of Atlanta using our 4-step model: engage, enroll, navigate and house. In Fiscal Year 2022, Intown Case Managers engaged 853 individuals experiencing homelessness and moved 270 individuals into permanent housing.
